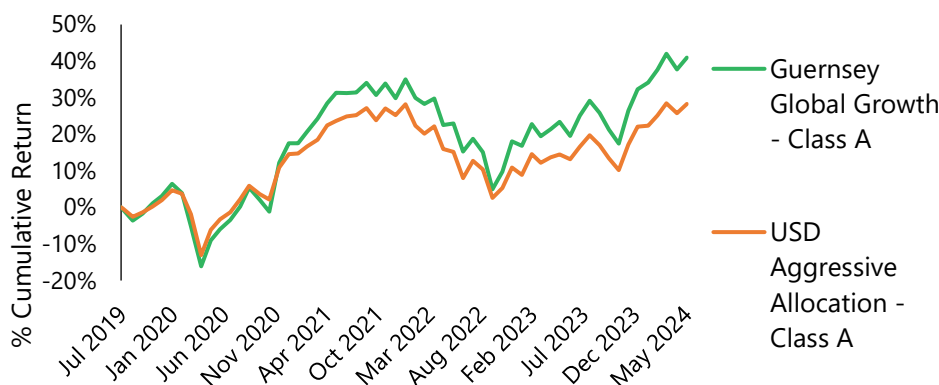
Investment Objective & Summary

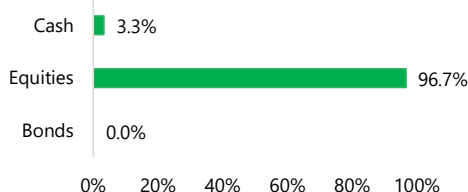
